## KOA – Kitchen Sustenance Program

The **program objective** is to support the KP families in Kashmir valley and help them make their ends meet during the hard times. 44 families in Kashmir valley are suffering from COVID related hardships and have requested assistance of about Rs 2000/- per month per family

- The program was advertised by word of mouth and via the coordinators Valley
- Program is active and supporting 44 family's on monthly basis

- List of **55 families** received from our associates in valley
- The support packages were developed with necessary food supplies
- Distribution of the packages done on monthly / bi-monthly basis depending on the feasibility and situation on ground.
